Often issues between the Regulator and the regulated community appear to be headed towards an impasse with no relief in sight. Situations frequently arise where the Regulated wants to implement a business model, but that model creates consequences for other industry members or constituents. This is exactly what happened with New Jersey's craft brewery industry. A 2012 law granted craft breweries limited retail privileges, which potentially conflicted with the privileges of retail consumption licensees. Using his skills as a consensus builder, NJ ABC Director and former legislator David Rible pulled together members of the craft brewery associations, the New Jersey Licensed Beverage Association and the New Jersey Restaurant Association to create a dialogue that is expected to solve this almost intractable problem. Please join Director Rible and members of these licensee groups for a round table discussion on the process that brought them all to the table to develop a solution.

That case dealt specifically with out-of-state wineries wanting to sell and ship their wines across state lines directly to consumers. Ever since then, retailers have sought equal access to the "DtC" business model, and

the creation of a national marketplace for wine. Do they finally have a ticket to the SCOTUS for the chance to make their case?

Nationally-recognized alcohol law attorney Richard Blau will lead an all-star panel of academics, advocates and administrators as they explore the Tennessee litigation embraced by interstate retailers in Tennessee Wine & Spirits Retailers Association v. Byrd. Also on tap will be a host of additional legal developments raising constitutional law issues that go to the heart of alcohol regulation in the 21st Century, including:

- U.S. District Judge Douglas Harpool's recent ruling in Missouri Broadcasters Association vs. Dorothy Taylor a decision that suggests the existence of too many exceptions can eviscerate the enforceability of a state's alcohol beverage laws.
- U.S. District Judge Wilhelmina Wright's order in Alexis Bailly Vineyard, Inc. et al v. Dohman, dismissing a lawsuit filed by two Minnesota wineries over a state alcohol law that restricts the source of grapes they can use.
- Mississippi's pending litigation suing out-of-state retailers Wine Express Inc. of New York; the California Wine Club of Ventura, the Gold Medal Wine Club of Santa Barbara, California and Bottle Deals Inc. of Syosset, New York for selling and shipping wines directly to Mississippi consumers.
