## **NCSLA 2013 Conference Presents “Why Do You Want To Know Who I Am? Complex Ownership versus Licensing Requirements”**

Are these structures really just developed for tax optimization or is there more to it? What types of model legislation can be applied to help bring down the barriers to entry and alleviate delay? This panel will continue and build upon the interactive discussion that started in Oklahoma City at last October’s Northern/Southern regional conference, and take it to the next level.
