BRUCE BAILEY is the Chairman of the Nebraska Liquor Control Commission. As co-founder and partner of the architecture and engineering firm, Design Associates, located in Lincoln, Nebraska, Bruce Bailey has 45 years' experience as a real estate developer. His firm has developed many businesses over the years, some with alcohol licenses, in six countries and 26 states. In 2015, Mr. Bailey was appointed by Gov. Ricketts to the Nebraska Liquor Control Commission, where he now sits as Chairman. Retired and living in Nebraska, Mr. Bailey continues to serve on several community boards and foundations with emphasis on senior adult & youth projects.

DEBBI BEAVERS joined the Kansas ABC in January 2004. In 2010, she was promoted to licensing manager and promoted to operations manager in 2015. She was appointed interim ABC Director in 2016 and was confirmed by the Senate in January 2017. Debbi is the first female director since the inception of ABC in 1949 and serves at the pleasure of the Secretary of Revenue.

Debbi's priorities for the ABC Division are to regulate the industry consistently, provide excellent customer service and increase compliance with liquor laws through education and training.

Prior to joining the Kansas ABC, Debbi lived in Missouri and worked in the private sector as a Medicare compliance analyst and also a social services director. Debbi studied at Missouri Western State College and has an associate's degree in travel.

CORY BOMGAARS started his career at Les Bourgeois Vineyards in 1991 as a salesperson in the Tasting Room and A-Frame and occasionally assisted in the vineyards and winery. Cory directly oversees the wine production and operations of 60 acres of Les Bourgeois vineyards and has developed successful partnerships with LBV's contract growers and assists them with his knowledge of vineyard management best practices.

Through three decades of wine making at Les Bourgeois Vineyards, Cory has been instrumental in the company's tremendous growth and success LBV is actively involved in custom crush, contract bottling and copacking for other wineries, retailers and wholesalers. Vineyards and coordinates the compliance issues between selling and manufacturing for all tiers of the Missouri three tiered system.
